**INTRODUCED BY** Jeanie Lauer, County Legislator

WHEREAS, by Ordinance 4925, dated October 31, 2016, the Legislature did authorize a Sub-Agreement with the California State University, Fresno Foundation, to furnish research and statistical analysis and consultation in connection with the SMART Prosecution grant, for the period of November 7, 2016, through September 30, 2018, at a cost to the County not exceed \$70,000.00;

and,

WHEREAS, the Prosecuting Attorney's Office now recommends an extension to the Agreement with Ryan Samuelson to serve as the Community Engagement Coordinator for the period ending September 30, 2019, at no additional cost to the County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute an extension to the Agreement with Ryan Samuelson of Kansas City, MO, for the period ending September 30, 2019, in a form to be approved the County Counselor.
