## **RESOLUTION NO. 20225**, August 12, 2019

**INTRODUCED BY** Charlie Franklin, County Legislator

WHEREAS, by Executive Order No. 19-18, the County Executive appointed Dr. Marius C. Tarau,

M.D., to serve as the County's Chief Medical Examiner effective June 3, 2019; and,

WHEREAS, Dr. Lindsey Haldiman, D.O., continues to serve as Deputy Medical Examiner; and,

WHEREAS, in an effort to support professional management for Jackson County, the County Executive recommends employment agreements for these top-level management positions with the County; and,

WHEREAS, the agreements outline the basis for continued employment, termination, and severance, a practice that is recommended by the International City/County Management Association and promotes the separation of the professional management of the County from political offices; and,

WHEREAS, an increase in compensation for Dr. Tarau and Dr. Haldiman is warranted for the reason of competing agencies offering a higher compensation than their current rates of pay; and,

WHEREAS, the County Executive and Dr. Tarau and Dr. Haldiman have reached an agreement for the increase of compensation; and,

WHEREAS, this level of compensation will allow the County to retain their services, which is critical to the operations of the Medical Examiner's Office; and,

WHEREAS, the execution of these Employment Agreements is in the best interests of the health, welfare, and safety of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive be and hereby is authorized to execute the attached Employment Agreements on behalf of the County; and, BE IT FURTHER RESOLVED that all County officials be and hereby are authorized to undertake all

actions required by this Agreement.

..Enacted and Approved Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
