ORDINANCE NO. 5272, September 30, 2019

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part

thereof, are amended by changing the boundaries of the "AG" (Agricultural) District and the

"RE" (Residential Estates) District, so that there will be transferred from District AG to District RE, a

tract of land located in section 33, township 48. Range 30 Jackson County, with a street address of

10321 S. Perdue Road, legally described as follows:

Description: Lot 1A, Replat of Lot 1, High Meadows

Section 2. The Legislature, pursuant to the application of Rex D and Mary Ann Luchtel (RZ-2019-

574), requesting the amendment embodied in this Ordinance and with notice that the Jackson

County Plan Commission voted 6 to 0 to recommend <u>APPROVAL</u> of this application after a public

hearing on September 19, 2019, does adopt this Ordinance pursuant to the Jackson County Charter

authorizing the Legislature to exercise legislative power pertaining to planning and zoning.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
