WHEREAS, by Resolution 20136, dated April 4, 2019, the Legislature did authorize the execution of a Program Agreement with the Missouri Department of Health and Senior Services and the U.S. Department of Agriculture for participation by Health Services in a summer food service inspection

program; and,

WHEREAS, Health Services has received reimbursement of costs for the inspections related to this program; and,

WHEREAS, an appropriation is necessary to place these funds in the appropriate spending account to be used to reimburse the cost of supplies used in the program; now therefore,
