WHEREAS, by Resolution 18833, dated June 1, 2015, the Legislature did award a twelve-month term and supply contract with three twelve-month options to extend for the furnishing of outpatient substance abuse treatment for use by the Prosecuting Attorney's Office's Drug Court Program to

Request for Proposals No. 7-15; and,

WHEREAS, the Prosecuting Attorney's Office has requested and the Director of Finance and

Purchasing recommends an extension of this term and supply contract; and,

WHEREAS, the extension will be effective from October 1, 2019, to March 31, 2020; and,

WHEREAS, this extension will allow the continued and uninterrupted provision of services for drug

court participants while the Prosecuting Attorney's Office researches and reevaluates its treatment

program; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, the contract with

Heartland Center for Behavioral Change be extended through March 31, 2020, as recommended by

the Director of Finance and Purchasing, and that the Director be, and hereby is, authorized to

execute for the County any documents necessary to the accomplishment of the extension; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all

payments, including final payment on the contract and extension thereto.
