WHEREAS, the Public Works Department has a need for parts and repair services for the hydraulic systems in use by the Road and Bridge Division; and,

WHEREAS, the Director of Finance and Purchasing has solicited formal written bids on Invitation to

Bid No. 52-19 for parts and repair services for the County's hydraulic systems; and,

WHEREAS, the only bid received was from Calibrated Products, Inc., of Blue Springs, MO; and,

WHEREAS, pursuant to section 1054.6 of the <u>Jackson County Code</u>, the Director of Finance and Purchasing recommends the award of a twelve-month term and supply contract with one twelve-month option to extend for the furnishing of hydraulic systems parts and repair services for use by the Public Works Department to Calibrated Products, Inc., of Blue Springs, MO, under the terms and conditions of Invitation to Bid No. 52-19, as the lowest and best bid received; and,

WHEREAS, this award is made on an as needed basis and does not obligate the County to pay any specific amount, with the availability of funds for specific purchases subject to annual appropriation; now therefore.

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing and that the Director be, and hereby is, authorized to execute for the County any documents necessary to the accomplishment of the award; and.

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be, and hereby is authorized to make all payments, including final payment on the contract.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
