WHEREAS, the Director of Finance and Purchasing has solicited formal written bids on Bid No. 55-19 for the furnishing of vending machine services for use countywide; and,

WHEREAS, a total of twenty-four solicitations were distributed and one response was received and

File #: 20341, Version: 0 evaluated as follows: **COMMISSION PERCENTAGE BIDDER** (Payable to County) Allied Refreshment, Kansas City (Jackson County), MO 40% and, WHEREAS, the Director of Finance and Purchasing recommends the award of a thirty-six month contract with two twelve-month options to extend to Allied Refreshment Company, Inc., of Kansas City (Jackson County), MO, under the terms and conditions of Invitation to Bid No. 55-19, as the highest and the best bidder; and, WHEREAS, this is a revenue generating contract and the term and extensions recommended are required to make it financially viable for the vendor to provide, maintain, insure, and pay taxes on the required equipment; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents necessary to the accomplishment of the award.
