INTRODUCED BY Tony Miller, County Legislator

WHEREAS, the Director of Finance and Purchasing has solicited formal written bids on Invitation to

Bid 56-19 for the furnishing of electrical services for use by the Parks + Rec and Public Works

Departments; and,

WHEREAS, a total of thirty-seven notifications were distributed and seven responses were received, one of which was rejected as non-compliant with the proposal requirements, and with the remaining

responses from the following:

and,

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Director of Finance and Purchasing recommends the split award of twelve-month term and supply contracts, with one twelvemonth option to extend, for the furnishing of Electrical Services for use by the Parks + Rec and Public Works Departments to Staco Electric Construction of Kansas City (Jackson County), MO and Kansas City Service Company of Peculiar, MO, under the terms and conditions of Request for Proposals No. 56-19; and,

WHEREAS, a spilt award to the two lowest and best bidders is recommended to ensure the

availability of more than one vendor for work as the need arises, in case the initially identified vendor is not available; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director of Finance and Purchasing be and hereby is authorized to execute for the County any documents necessary for the accomplishment of the award and any necessary extensions; and,

BE IT FURTHER RESOLVED that the Department of Finance and Purchasing is authorized to make all payments, including final payment on the contracts, to the extent that sufficient appropriations to the using spending agencies are contained in the then current Jackson County budget.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
