WHEREAS, by Resolution 18600, dated September 2, 2014, the Legislature did authorize the Interlocal Cooperative Agreement with the Cities of Kansas City, Missouri, Overland Park, Kansas, and Loch Lloyd Country Club for the Kenneth Road Bridge replacement project; and,

WHEREAS, this agreement allows for the project to use up to \$3,000,000.00 from off-system bridge

funds allocated to the County; and,

WHEREAS, the other parties will contribute cash to fully fund the project; and,

WHEREAS, the City of Kansas City has accepted bids for the construction on the bridge and is in the

process of awarding the contract; and,

WHEREAS, the attached Amendment No. 1 to the agreement will adjust the funding to the actual

costs based on the construction bid, and the obligation of the County will remain the same as in the

original agreement; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute the attached Amendment No. 1 to the Interlocal Cooperative

Agreement with the Cities of Kansas City, Missouri, Overland Park, Kansas, and Loch Lloyd Country

Club.
