**ORDINANCE NO. 5325**, April 6, 2020

WHEREAS, U.S. President Donald J. Trump, Missouri Governor Mike Parson, and County Executive Frank White Jr. have all declared, in one form or another, the ongoing coronavirus/COVID-19 pandemic to be a public health emergency; and,

WHEREAS, on March 22, 2020, the County Executive issued an order closing all non-essential

businesses in Jackson County, outside the City of Kansas City, until at least April 24, 2020; and,
WHEREAS, the closing of businesses required under the order may render it a hardship for business
owners to pay certain fees for licenses and permits due under the Jackson Code; now therefore,
BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that fees for license and
permit renewals due under chapter 40, Food Safety and Environmental Health, chapter 41, Alcoholic
Beverages, and chapter 42, Amusements, <u>Jackson County Code</u> , 1984, be and hereby are deferred
until October 1, 2020, to enable businesses to better cope with the financial issues relating to the
closure order relating to COVID-19.
Effective Date: This ordinance shall be effective immediately upon its signature by the County Executive.
