WHEREAS, by Resolution 18729, dated February 17, 2015, the Legislature did award a contract for website design for use by the Information Technology Department to Civic Plus of Manhattan, KS, at a cost to the county not to exceed \$145,000.00; and,

WHERAS, the County has annually contracted since that time with Civic Plus for the annual

maintenance of its proprietary website maintenance software, as a sole source; and,
WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Director of Finance and
Purchasing again recommends a contract with Civic Plus of Manhattan, KS, as a sole source
purchase, based upon Civic Plus's status as the sole provider of maintenance for its own proprietary
website software; now therefore,
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the contract be
awarded as recommended by the Director of Finance and Purchasing, and that the Director be, and
is hereby, authorized to execute for the County any documents necessary for the accomplishment of
the award; and,
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all
payments, including final payment, on the contract.
