WHEREAS the County's currently leased inventory of copiers are seven years old and have reached the end of their usable lifecycle; and,

WHEREAS, the Director of Finance and Purchasing has solicited bids on Invitation to Bid No. 28-19 for the furnishing of leased copier services for use County-wide; and,

WHEREAS, a total of twenty-nine notifications were distributed and eight responses were received

and evaluated; and,

WHEREAS, following an evaluation of the bids submitted, the Director of Finance and Purchasing

recommends a split award to All Copy Products of Lenexa, KS, and GFI Digital of Kansas City, KS,

as the lowest and best bids received, due to discounts offered on the items of equipment most in

demand, as set out in the attached abstract of bids; and,

WHEREAS, the three-year term and extensions will allow the County to take advantage of

substantial discounts on the monthly payments for the equipment; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay

any specific amount, with the availability of funds for specific purchases subject to annual

appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the award be made

as recommended and that the Director of Finance and Purchasing be and hereby is authorized to

execute for the County any documents necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make

all payments, including final payment on the contracts, to the extent that sufficient appropriations to

the issuing spending agencies are contained in the then current Jackson County budget.
