## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** amending the zoning districts established pursuant to the Unified Development Code by rezoning a certain 80.00± acre tract from District AG (Agricultural) to District RR (Residential Ranchette) and approving the preliminary plat "Peaceful Ridge," creating a thirteen-lot residential subdivision.

**ORDINANCE NO. 5349**, June 1, 2020

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RR" (Residential

Ranchette) Districts, so that there will be transferred from District AG to District RR a tract of land located in section 24, township 47, range 30, Jackson County, at 150 Highway and Hutt Road, Jackson County, MO, legally described as follows:

Description: The South Half of the Southwest Quarter of Section 24, Township 47, Range 30, in Jackson County, Missouri.

<u>Section 2</u>. The preliminary plat "Peaceful Ridge," creating a thirteen-lot residential subdivision, is hereby approved.

<u>Section 3</u>. The Legislature, pursuant to the application of Steven E. Accurso (RZ-2020-577), requesting the amendment and approval embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 6 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on May 21, 2020, does hereby adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
