WHEREAS, after a thorough investigation and negotiations, the County Counselor recommends a settlement of this case in the amount of \$50,000.00 to be paid by the County to Nichole Renee Aguirre, Dominic Michael Bonavia, Joe Carl Anthony Boniva, and Mika Rae Thurman and/or attorneys Cynthia Dodge and John Kurtz; and,

WHEREAS, the proposed settlement will limit the County's financial obligation in this matter and is in the best interests of the health, safety, and welfare of the citizens of Jackson County; now therefore,
