WHEREAS, U.S. President Donald J. Trump, Missouri Governor Mike Parson, and County Executive

Frank White, Jr., have all declared, in one form or another, the ongoing Coronavirus/COVID-19

pandemic to be a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its

citizens; and,

WHEREAS, an appropriate response by the County to this emergency will require significant

expenditures from the County CARES Act Fund, which consists of monies provided by the U.S.

Treasury for this purpose; and,

WHEREAS, the Mid-Continent Public Library of Kansas City, MO, has submitted a proposal to

address internet connectivity issues for students in the County brought on by the migration to virtual

classrooms for the 2020-2021 school year, triggered by COVID-19 pandemic, at a cost to the County
