WHEREAS, U.S. President Donald J. Trump, Missouri Governor Mike Parson, and County Executive

Frank White, Jr., have all declared, in one form or another, the ongoing Coronavirus/COVID-19

pandemic to be a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its

citizens and employees; and,

WHEREAS, an appropriate response by the County to this emergency will require significant

expenditures from the County CARES Act Fund, which consists of monies provided by the U.S.

Treasury for this purpose; and,

WHEREAS, with the \$1,500,000.00 funding provided by this Ordinance, the United Way of Greater

Kansas City (UWGKC) will provide support to residential tenants within Jackson County who are

facing eviction as a result of the pandemic, as further outlined in UWGKC's attached funding

proposal; and,

WHEREAS, the funding provided by this Ordinance will allow UWGKC to leverage additional private

community and other governmental support for a total program cost of \$2,200,000.00; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following
