WHEREAS, the Director of Finance and Purchasing recommends the award of a contract for the furnishing of HR/payroll system for use by the Information Technology Department; and,

WHEREAS, additionally, the Human Resources Director requests that she be able to implement an

Affordable Care Act component to be added to the contract awarded by Ordinance 4229, dated August 23, 2010, to Paycor, Inc., of Cincinnati, OH, to allow for the creation of IRS forms quickly and efficiently, saving manpower; and,

WHEREAS, section 1030.1, <u>Jackson County Code</u>, 1984, eliminates the requirement for competitive bidding when items to be purchased can be obtained from only one source; and,

WHEREAS, the Director of Finance and Purchasing further recommends that he not take competitive bids for this equipment and software for the reason that Paycor, Inc., is the current provider of the County's HR/payroll system and award to Paycor will allow the County to continue its satisfactory operations without incurring the significant start-up costs that would be associated with conversion to a new vendor; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with availability of funds for specific purchases subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing, and that the Director be and hereby is authorized to execute for the County any documents, including future options to extend, necessary for the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance is authorized to make all payments, including final payment on the contract, to the extent that sufficient appropriations are
