AN ORDINANCE amending the zoning districts established pursuant to the Unified Development Code by rezoning a certain 2.14± acre tract from District AG (Agricultural) to District RE (Residential Estates).

ORDINANCE NO. 5427, October 19, 2020

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RE" (Residential Estates) Districts, so that there will be transferred from District AG to District RE a tract of land, with a street address of 9806 Timber Meadow Drive, Jackson County, MO, legally described as follows:

Description: Lot 88, Timber Meadows, a subdivision in Jackson County, Missouri.

Section 2. The Legislature, pursuant to the application of Dusty Wilde and Danielle Stephenson (RZ-
2020-591), requesting the amendment embodied in this Ordinance and with notice that the Jackson
County Plan Commission voted 7 to 0 to recommend <u>APPROVAL</u> of this application after a public
hearing on September 24, 2020, does hereby adopt this Ordinance pursuant to the Jackson County
Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
