## **ORDINANCE NO. 5458,** November 23, 2020

WHEREAS, U.S. President Donald J. Trump, Missouri Governor Mike Parson, and County Executive

Frank White, Jr., have all declared, in one form or another, the ongoing Coronavirus/COVID-19

pandemic to be a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its citizens and employees; and,

WHEREAS, an appropriate response by the County to this emergency will require significant expenditures from the County CARES Act Fund, which consists of monies provided by the U.S. Treasury for this purpose; and,

WHEREAS, this appropriation will provide funds to the Department of Corrections for weekly COVID-19 testing and laboratory services for staff and inmates at the Jackson County Detention Center for the remainder of 2020; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be and hereby is made:
