WHEREAS, pursuant to section 1054.6, Jackson County Code, 1984, the Director of Finance and Purchasing recommends the award of a twelve-month term and supply contract for the furnishing of certified laboratory urinalysis testing, with one twelve-month option to extend, to Avertest, LLC., dba Averhealth of Richmond, Virginia, as the lowest and best bidder meeting specifications; and,

appropriations to the using spending agency are available in the then current Jackson County budget.
