BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Prosecuting Attorney be and is hereby authorized to execute Cooperative Agreements with the cities of Blue Springs, Buckner, Grain Valley, Grandview, Independence, Lee's Summit, Oak Grove, and Sugar Creek and the Kansas City Board of Police Commissioners, at an aggregate cost to the County not to exceed \$1,361,836.00, in forms to be approved by the County Counselor; and,

BE IT FURTHER RESOLVED that the Director of the Department of Finance and Purchasing be and hereby is authorized to make all payments, including final payment on the contracts.

Effective Date: This Resolution shall be effective immediately upon its passage by a majority of the Legislature.
