## IN THE COUNTY LEGISLATURE OF JACKSON COUNTY, MISSOURI

**AN ORDINANCE** amending the zoning districts established pursuant to the Unified Development Code by rezoning a certain 5.10± acre tract from District AG (Agricultural) to District RR (Residential Ranchette).

ORDINANCE NO. 5485, February 8, 2021

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part

thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RR" (Residential

Ranchette) Districts, so that there will be transferred from District AG to District RR a tract of land located at 7702 S. Hillside School Road, legally described as follows:

Lot 1, Garver Acres, 1<sup>st</sup> Plat, a subdivision in Jackson County, Missouri.

Section 2. The Legislature, pursuant to the application of Michael E. & Aletta A. Cox (RZ-2021-596),

requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan

Commission voted 5 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on

January 21, 2021, does hereby adopt this Ordinance pursuant to the Jackson County Charter

authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
