ORDINANCE NO. 5498, April 19, 2021

WHEREAS, by Resolution 20551, dated November 2, 2020, the Legislature did authorize the auction of park property declared surplus; and,

WHEREAS, the Director of Parks + Rec desires to purchase kayaks for use at the Lake Jacomo Marina and recommends that the auction proceeds, in the amount of \$5,600.00, be made available for this purpose; and,

WHEREAS, an appropriation is necessary to place the auction proceeds in the proper spending

account so that the funds may be used to purchase the needed equipment; now therefore,
