WHEREAS, the Cave Spring Association has managed operation and programming of William M.

Klein Park, also known as the Cave Spring Park and Historic Site, on behalf of Jackson County since

1981, providing for daily maintenance of park facilities, and offering a variety of historical and

educational programs for the public; and,

WHEREAS, by Resolution 20388, dated March 30, 2020, the Legislature did authorize a

Memorandum of Understanding (MOU) further outlining and clarifying the responsibilities of the

County and the Cave Spring Association and authorized funding for the Cave Spring Association in

the amount of \$25,000 for the year 2020, with funding for future years subject to budgeting and

annual appropriation; and,

WHEREAS, the Director of Parks + Rec recommends the execution of the attached Amendment to

the MOU with the Cave Spring Association to provide for continued funding by the County in the

annual amount of \$25,000, for the Association's daily management, operation, maintenance,

programming, and improvement of the Cave Spring Park and Historic Site; and,

WHEREAS, this Amendment to the MOU creates no employment relationship between Cave Spring

Association and the County; and,

WHEREAS, the execution of the attached Amendment to the MOU is in the best interests of the

health, safety, and welfare of the citizens of Jackson County; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the Director of Parks
