BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section 1. The Zoning Order of Jackson County, Missouri, and the official maps which are a part

thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RR" (Residential

Ranchette) Districts, so that there will be transferred from District AG to District RR a tract of land,

legally described as follows:

The East Half of the East Half of the South Half of the Southeast Quarter of the Southwest Quarter of Section 29, Township 47, Range 30, Jackson County, Missouri.

<u>Section 2</u>. The Legislature, pursuant to the application of Eugene and Michelle Land Trust (RZ-2021-608), requesting the amendment embodied in this Ordinance and with notice that the Jackson County Plan Commission voted 5 to 0 to recommend <u>APPROVAL</u> of this application after a public hearing on July 15, 2021, does hereby adopt this Ordinance pursuant to the Jackson County Charter authorizing the Legislature to exercise legislative power pertaining to planning and zoning.
