ORDINANCE NO. 5533, August 9, 2021

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. The Zoning Order of Jackson County, Missouri, and the official maps which are a part thereof, are amended by changing the boundaries of the "AG" (Agricultural) and "RS" (Residential Suburban) Districts, so that there will be transferred from District AG to District RS a tract of land, legally described as follows:

15, 2021, does hereby adopt this Ordinance pursuant to the Jackson County Charter authorizing the							
Legislature to exercise legislative power pertaining to planning and zoning.
