WHEREAS, by Resolution 19503, dated June 5, 2017, the Legislature did award a thirty-six month term and supply contract with two twelve-month options to extend for the furnishing of inmate pay telephone services for use by the Department of Corrections with Securus Technologies of Dallas, TX, under the terms and conditions of Invitation to Bid No. 71-16; and,

WHEREAS, under the proposed final extension, Securus Technologies will provide all required pa					
telephones and pay tablet services for a flat commission payable to the County in the amount of					
\$41,666.67/month; and,					
WHEREAS, the attached Addendum and extension will allow the continued and uninterrupted					
furnishing of inmate phone services through May 31, 2022; now therefore,					
BE IT RESOLVED by the County Legislature of Jackson County, Missouri, the contract with Securus					
Technologies, be extended as recommended by the Director of Finance and Purchasing, and that the					
Director be, and hereby is, authorized to execute for the County any documents necessary to the					
accomplishment of the extension and Addendum; and,					
BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make al					
payments, including final payment on the contracts and extension and Addendum thereto.
