WHEREAS, the Sheriff's Office has experienced shortfalls in its budget due to mobile phone expenses for 2021 being higher than anticipated; and,

WHEREAS, to avoid a deficit in the account and continue uninterrupted mobile phone service, a transfer is required; now therefore,
