return KZPT will provide the Parks + Rec Department \$25,000.00 in air time to be used for

obligations of the parties; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the County Executive

be and hereby is authorized to execute the attached License and Professional Services Agreement

with KZPT; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to make all payments, including final payment on the agreement.
