WHEREAS, the Jackson County Drug Task Force (JCDTF) and the U.S. Drug Enforcement Administration have formed the Organized Crime Drug Enforcement Task Force (OCDETF) to conduct a joint federal drug investigation, OCDETF Case No. WC-MOW-351, "Operation Nose to the Grindstone," for the period of October 1, 2021, through September 30, 2022; and,

WHEREAS, a portion of the overtime costs incurred by the JCDTF for this investigation will be reimbursed by the OCDETF, in an amount not to exceed \$10,000.00; and,
