WHEREAS, after legislative approval of the contract it was determined there was an irregularity in

WHEREAS, since that determination, the Director of Finance and Purchasing solicited proposals on

Request for Proposals (RFP) No. 72-21 for the furnishing of employee group dental insurance

coverage as an employee benefit for use countywide; and,

WHEREAS, a total of twelve notifications were distributed and two responses were received and

evaluated from the following:

WHEREAS, pursuant to section 1054.6 of the Jackson County Code, the Directors of Finance and Purchasing and Human Resources recommend the award of a twelve-month term and supply contract with one twelve-month option to extend for the furnishing of employee group dental insurance coverage as an employee benefit for use countywide to Blue Cross and Blue Shield of Kansas City, MO, under the terms and conditions of RFP No. 72-21, for the reason that it has submitted the lowest and best proposal;

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any specific amount, with the availability of funds subject to annual appropriation; and,

WHEREAS, the total monthly premium costs of Blue Cross dental plans for 2022 by plan type and rate option are as follows:
