WHEREAS, pursuant to Resolution 20153, dated April 29, 2019, the County Counselor executed a Legal Services Agreement with the law firm of Seyferth, Blumenthal & Harris, LLP, of Kansas City, MO, to provide specialized legal services in connection with the defense of a pending employment discrimination claim; and,

WHEREAS, a subsequent addendum has brought the total authorization under this contract up to the

amount of \$228,650.00; and,
WHEREAS, the County Counselor recommends that he be authorized to execute a Third Addendum
to the Legal Services Agreement to provide for additional compensation to be payable to the firm in
the amount of \$140,000.00; now therefore,

be and hereby is authorized to execute the attached Third Addendum to the Legal Services
Agreement with Seyferth, Blumenthal & Harris, LLP, of Kansas City, MO, for services to be performed

hereby is authorized to make all payments, including final payment, on the Addendum.
