WHEREAS, after a thorough investigation and negotiations, the County Counselor and special counsel recommend a settlement in the amount of \$67,000.00, to be paid by the County to Christopher Miller and/or his attorney, Marc N. Middleton; and,

\$67,000.00, in full, final, and complete release of all of the claims against the County and all of its

employees, officers, agents, and servants, as to any damages incurred; and,

and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to issue a check or checks in an amount totaling \$67,000.00 in full and complete

settlement of this claim, payable to Christopher Miller and/or his attorney Marc N. Middleton d/b/a
