**ORDINANCE NO. 5618**, April 11, 2022

**INTRODUCED BY** Ronald E. Finley, County Legislator

WHEREAS, the Family Court Division has been awarded additional funds in the amount of \$65,111.80 for the Jackson County Disproportionate Minority Contact (DMC) Coordinator grant by the Missouri Department of Public Safety for the period of October 1, 2021, through September 30, 2022; and,

WHEREAS, the goal of this program is to provide a DMC Coordinator who will oversee the Jackson

County DMC initiative to examine potential disproportionate minority disparities in the justice continuum and implement data-based prevention and system improvement strategies to reduce identified disparities in treatment of system-involved youth; and,

WHEREAS, the grant does not require local matching funds; and,

WHEREAS, an appropriation is necessary to place the additional grant funds in the proper spending account; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following appropriation be made from the undesignated fund balance of the 2022 Grant Fund:
