ORDINANCE NO. 5634, June 13, 2022

WHEREAS, the County has been awarded a reimbursement grant by the Missouri Highways and Transportation Commission under the Federal Lands Access Program, in the amount of \$760,000.00; and,

WHEREAS, the grant proceeds and the required \$190,000.00 in local matching funds will be used for the repair and overlay of 2.5 miles of roadway and parking areas at Blue Springs Lake; and,

WHEREAS, an appropriation and transfer are necessary in order to place the grant and matching funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation be and hereby are made:
