WHEREAS, the Sheriff's Office desires to continue to use Whelan equipment to ensure ease of maintenance, and to avoid the need to stock replacement parts from multiple manufacturers; and,

WHEREAS, 911 Custom of Overland Park, KS, is the only authorized dealer for Whelan equipment in

the greater Kansas City metropolitan area; and,

WHEREAS, pursuant to section 1030.1 of the Jackson County Code, the Sheriff and the Director of

Finance and Purchasing recommend the award of a twelve-month term and supply contract with two

twelve-month options to extend for the furnishing, installation, and repair of emergency equipment for

use by the Sheriff's Office to 911 Custom of Overland Park, KS, as a sole source purchase; now

hereby, authorized to execute for the County any documents necessary to the accomplishment of the

payments, including final payment on the contract, to the extent that sufficient appropriations to the

using spending agency are contained in the then current Jackson County budget.
