authorized to issue a check or checks in an amount totaling \$150,000.00 in full and complete

settlement of this claim, payable to Linda Hengel and/or her attorney Katherine Myers d/b/a Edelman,

Liesen & Myers, LLP, pursuant to the specific direction of the County Counselor.
