against the County and all of its employees, officers, agents, and servants, as to any damages

incurred; and,

BE IT FURTHER RESOLVED that the County Counselor be and hereby is authorized to execute any

and all documents necessary to effect this settlement; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing be and hereby is

authorized to issue a check or checks in an amount totaling \$255,000.00 in full and complete

settlement of this claim, payable to Charlotte Hardin and/or her attorney Katherine Myers d/b/a

Edelman, Liesen & Myers, LLP, pursuant to the specific direction of the County Counselor.
