ORDINANCE NO. 5695, November 7, 2022

INTRODUCED BY Tony Miller, County Legislator

WHEREAS, by Ordinance 5651, dated August 15, 2022, the Legislature did authorize the

acceptance of a grant in the amount of \$138,689.00 awarded by the Missouri Department of Social

Services for the Victims of Crime Act (VOCA) grant, for the period April 1, 2022, through September

30, 2022; and,

WHEREAS, the Missouri Department of Public Safety has now awarded additional grant funds in the

amount of \$277,378.00, and authorized a further twelve-month extension to the VOCA grant, through

September 30, 2023; and,

WHEREAS, this additional allocation requires local matching funds in the amount of \$95,855.00 to cover the unfunded portions of the program; and,

WHEREAS, an appropriation and transfer are necessary in order to place the grant and matching funds in the proper spending accounts; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, that the following transfer and appropriation be and hereby are made:
