WHEREAS, the Blue River Parkway is a Jackson County linear park located along the Blue River; and,

WHEREAS, the Parks + Rec Department has worked over the past year to develop a new Master

Plan for the parkway; and,

WHEREAS, the plan documents the park's high value to the community as a place for recreation,

enjoyment, and wellness, while recognizing the incredible natural resources that are protected within

the park's boundaries; and,

WHEREAS, the citizens of Jackson County, stakeholders, and everyday park users were engaged to

provide input and feedback that were included among the goals and priorities for the park's future

development; and,

WHEREAS, stakeholder focus groups and public meetings were hosted across the Blue River

watershed, over 800 responses were received from an online and written needs assessment survey,

and a project website was launched to provide project information and solicit additional input;

and,

WHEREAS, the proposed Master Plan includes protecting the park in perpetuity as a recreational

and open space asset, increasing visibility, use, accessibility, and inclusiveness through new

partnerships and engagement programs, restoring natural areas, and making key capital

improvement investments to extend the trails network and improve recreational facilities and

amenities; and,
