## ORDINANCE NO. 5705, December 5, 2022

**INTRODUCED BY** Tony Miller, County Legislator

WHEREAS, the Director of the Parks + Rec Department has recommended that the department's

schedule of park fees and charges be adjusted to cover increased costs of providing services and to

impose fees for new services; and,

WHEREAS, said adjustments, as reflected in the attached Schedule I, are in the best interests of the

citizens of the County; now therefore,

BE IT ORDAINED by the County Legislature of Jackson County, Missouri, as follows:

Section A. Enacting Clause. Schedule I, Chapter 50, Jackson County Code, 1984, is hereby repealed

and one new schedule enacted in lieu thereof, to be known as Schedule I, to read as indicated on the

attachment.

Effective Date: This Ordinance shall be effective immediately upon its signature by the County Executive.
