WHEREAS, the County has a need for public safety supplies and equipment for use by various

County departments; and,

WHEREAS, pursuant to section 1030.4 of the Jackson County Code, the Director of Finance and

Purchasing recommends the award of a twelve-month term and supply contract with one twelvemonth option to extend, for the furnishing of these supplies and equipment to Galls of Lexington KY, under the terms and conditions of BuyBoard Contract No. 698-23, an existing government contract; and,

WHEREAS, this award is made on an as needed basis and does not obligate Jackson County to pay any amount, with the availability of funds for specific purchases remaining subject to annual appropriation; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that award be made as recommended by the Director of Finance and Purchasing and that the Director be and hereby, is authorized to execute for the County any documents necessary to the accomplishment of the award; and,

BE IT FURTHER RESOLVED that the Director of Finance and Purchasing is authorized to make all payments, including final payment on the contract, subject to the availability of funding in the current Jackson County budget.
