**ORDINANCE NO. 5734,** April 17, 2023

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

<u>Section 1</u>. A conditional use permit is hereby renewed for a period of twenty-five years to operate a campground, as to an approximate 21.8± acre tract of land in District AG (Agricultural), commonly known as 4023 N. Barnes Road in Jackson County, Missouri, legally described as follows:

**Description:** All that part of the Northwest Quarter of the Southeast Quarter of Section 2, Township 50, Range 31, lying East of the Little Blue River, containing 21.8 acres, more or less. Subject to any right-of-way, easements, or other reservation of record.
