**ORDINANCE NO. 5740, May 1, 2023**

WHEREAS, U.S. President Joseph R. Biden, Jr., Missouri Governor Mike Parson, and County

Executive Frank White, Jr., have all declared or affirmed, in one form or another, that the ongoing

Coronavirus/COVID-19 pandemic is a public health emergency; and,

WHEREAS, the County, through its various efforts, plays a significant role in the public health of its

citizens and employees; and,

WHEREAS, an appropriate response by the County to this emergency will require significant

expenditures from the County's American Rescue Plan Fund, which consists of monies provided by

the U.S. Treasury for this purpose; and,

WHEREAS, with the funding provided by this appropriation, the Jackson County Health Department

will maintain the continued efforts that include providing testing resources, vaccinations, and

community health worker referrals to mitigate the impact of COVID-19 on County residents; now

therefore,
