ORDINANCE NO. 5767, July 10, 2023

WHEREAS, the 1300 Washington Street Administration building is in need of improvements, build-

out, and furnishings in the amount of seventeen million; and,

WHEREAS, the allocation for the Washington Street Administration building will allow for bidding on

that construction project and allow for a future resolution to be approved by the County Legislature

for the award of such a contract; and,

WHEREAS, the second floor of the downtown Jackson County Courthouse is in need of a preliminary

allocation for construction improvements and furnishings in the amount of four million; and,

WHEREAS, the Historic Truman Courthouse is in need of a preliminary allocation for building

improvements in the amount of two million; and,

WHEREAS, both of the above preliminary allocations for the courthouses will allow design to

commence on these necessary renovations and allow for a future construction price and contract to

be approved for award by the County Legislature at a later date; and,
