## **RESOLUTION NO. 21369**, August 14, 2023

**INTRODUCED BY** Venessa Huskey, County Legislator

WHEREAS, at the election held April 4, 2017, the voters of Kansas City, Missouri, approved the

Central City Economic Development Sales Tax, Question 4, a retail sales tax of one-eighth (1/8) of

one cent for the support of development and revitalization along the Prospect Avenue corridor; and,

WHEREAS, approval of the question submitted authorized the creation of the Central City Economic

Development Sales Tax District Board and the imposition of the sales tax; and,

WHEREAS, section 67.1305, RSMo., the enabling legislation for the creation of the district, provides

that the district be governed by a board whose membership is to include a member selected by a majority vote of the Legislature; and,

WHEREAS, by Resolution 20288 dated October 14, 2019, the Legislature did reappoint Melissa Patterson-Hazley to this board; and,

WHEREAS, Ms. Patterson-Hazley was recently elected to the City Council of Kansas City, Missouri, and has submitted her resignation of this appointment; and,

WHEREAS, it is now appropriate that the Legislature adopt this Resolution appointing a member to fill the unexpired term of Ms. Patterson-Hazley; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that Jon H. Otto be and hereby is appointed to the Central City Economic Development Sales Tax District Board to fill the unexpired term occasioned by the resignation of Melissa Patterson-Hazley, for a term to expire November 14, 2023, under section 67.1305, RSMo.
