WHEREAS, the Sheriff's Office is in possession of public safety radio equipment that is no longer of use to the Sheriff's Office; and,

WHEREAS, pursuant to chapter 11 of the <u>Jackson County Code</u>, 1984, the Director of Finance and Purchasing recommends that said property be declared surplus and transferred to the Lone Jack Fire Protection District; and,

WHEREAS, the Lone Jack Fire Protection District is the only public safety agency that currently is not

a participant in the Metropolitan Area Regional Radio System (MARRS) and does not have current

radio equipment in order to stay in contact with the Jackson County Sheriff's Office, Lone Jack Police

Department, or the Jackson County Sheriff's Office Dispatch; and,

WHEREAS, the Lone Jack Fire Protection District is prepared to join MARRS, however does not yet

have compatible radio equipment; now therefore,

BE IT RESOLVED by the County Legislature of Jackson County, Missouri, that the specified public

safety radio equipment property within the Sheriff's Office, be and hereby is declared surplus, and

that the County Executive be and hereby is authorized to execute the attached Cooperative

Agreement pursuant to chapter 11 of the <u>Jackson County Code</u>, 1984.
