**AN ORDINANCE** setting the 2023 Jackson County Board of Services for the Developmentally Disabled (Sheltered Workshop) Levy.

**ORDINANCE NO. 5795**, September 18, 2023

INTRODUCED BY DaRon McGee, County Legislator

WHEREAS, pursuant to sections 205.968 through 205.973, RSMo, as amended, and the vote of the qualified voters of November 2, 1976, there was established for the Jackson County Board of Services for the Developmentally Disabled (Sheltered Workshop) a tax levy at the annual rate of ten cents per one hundred dollars of assessed valuation on all taxable property in Jackson County, Missouri; and,

WHEREAS, sections 137.073 and 137.115, RSMo, and Missouri Constitution, article X, section 22,						
require tax levies to be revised as a result of general reassessment; now therefore,						

BE IT ORDAINED by the County Legislature of Jackson County, Missouri that, after calculation of the revisions mandated by statute and the Constitution, there is hereby levied for the 2023 tax year the rate of seven and sixteen hundredths (7.16) cents per one hundred dollars of assessed valuation on all taxable property for the Jackson County Board of Services for the Developmentally Disabled (Sheltered Workshop).
