ORDINANCE NO. 5823, December 18, 2023

INTRODUCED BY Sean E. Smith, County Legislator

BE IT ORDAINED by the County Legislature of Jackson County, Missouri as follows:

Section A. Enacting Clause. Sections 9103. and 9104., <u>Jackson County Code</u>, 1984, are hereby repealed and two new sections enacted in lieu thereof, to be known as sections 9103. and 9104., to read as follows:

9103. <u>Salary</u>

Those permanent members of the Board of Equalization who are appointed by the County Executive [by reason of Subsection 1 of Section 1 of Article XI] <u>under Article XI</u>, <u>Section 1</u>, <u>Subsection 1</u> of the Jackson County Charter shall each receive a salary of one thousand five hundred dollars (\$1,500) per month that the Board of Equalization is in session less than an average of three days per week, except that they shall receive compensation of three thousand dollars (\$3,000) per month that the Board of Equalization is in session for an average of more than 3 days per week [for the months of July and August and except that such members shall receive four thousand dollars (\$4,000) per month for the months of September, October, November and December, 2019]. No compensation shall be payable to any member for any month in which that member does not personally attend a meeting of the Board.

9104. Compensation

Those members of the Board of Equalization appointed under [Subsections 2 and 3 of Section 1 of] Article XI, Section 1, Subsections 2 and 3 of the Jackson County Charter, who are eligible to receive compensation from Jackson County, shall each receive compensation of one hundred fifty dollars (\$150) per meeting that they attend and cast a vote in[, except that such members shall receive

after the effective date of Ordinance 524	49].
