WHEREAS, by Resolution 20841, dated December 13, 2021, the Legislature awarded an eleven-

month contract with two twelve-month options to extend Fred Dreiling, LLC, of Kansas City (Jackson

County) MO, to serve as the Legislature's Chief Lobbyist; and,

WHEREAS, in this capacity, the Chief Lobbyist's responsibilities include assessing the current

political climate in the State of Missouri, recommending appropriate strategies that would benefit the

County, informing the Legislature on all pertinent legislative issues, and providing lobbying service as

requested; and,

WHEREAS, currently Jackson County's Assessor is appointed by the County Executive and is not an

elected position; and,

WHEREAS, during the Jackson County's Legislative meeting dated July 10, 2023, the Chief Lobbyist

reported expecting a Missouri bi-partisan bill to require the Jackson County Assessor to be elected;

and,

WHEREAS, Missouri House Joint Resolution 115 introduced and read on January 9, 2024, is

proposing an amendment to the Constitution of Missouri to require Jackson County to have an

elected county assessor; and,

WHEREAS, it is the intent of the Legislature for the Chief Lobbyist to advocate to the Missouri
